Lowell Announces Extension of Expiration Time in Consent Solicitation Relating to

€630m Floating Rate Senior Secured Notes due 2026 (Regulation S Notes: ISIN XS2250154494, Common Code 225015449; Rule 144A Notes: ISIN XS2250154817, Common Code 225015481)

€795m 6.750% Senior Secured Notes due 2025 (Regulation S Notes: ISIN XS2250153769, Common Code 225015376 Rule 144A Notes: ISIN XS2250154148, Common Code 225015414)

£440m 7.750% Senior Secured Notes due 2025 (Regulation S Notes: ISIN XS2250155467, Common Code 225015546 Rule 144A Notes: ISIN XS2250155541, Common Code 225015554)

Further to the announcement dated May 5, 2025, Garfunkelux Holdco 3 S.A., (a public limited liability company (*société anonyme*) incorporated under the laws of the Grand Duchy of Luxembourg (the "**Issuer**", and together with its subsidiaries, the "**Group**") today announces the extension of the expiration time in its previously-announced consent solicitation (the "**Consent Solicitation**"), upon the terms of and subject to the conditions set forth in the consent solicitation statement dated May 5, 2025 (the "**Consent Solicitation**") which seeks consent from eligible holders of the Notes to approve an amendment to the Notes indenture (the "**Amendment**") as set out in the Consent Solicitation Statement.

To allow sufficient time for completion of legal documentation and other conditions precedent, the expiration time for the Consent Solicitation has been extended from 5.00pm (London time) on May 19, 2025, to 5.00pm (London time) on May 28, 2025 (such date and time, as may be further extended, the "**Expiration Time**"). The Consent Solicitation will expire at the Expiration Time, unless extended or terminated. All other terms of the Consent Solicitation remain unchanged. Each holder of the Notes who has previously submitted a consent does not need to resubmit such consent or take any other action in response to this extension.
